

eventeen year old Eric stepped off a bus in Aiken, SC with his two younger sisters, his younger brother and his mother. They had no bags, no money and no shoes. This was the fifth state for them in three years. They had no connections to South Carolina, no one they could call and nowhere to sleep. So they began walking. Eric, his mother and siblings walked every mile from Aiken to Columbia in bare feet.

When they got to Columbia, someone picked the family up and took them to the hospital. It didn't take long for the hospital staff to realize the family had nowhere to go, and the SC Department of Social Services was contacted. Eric and his two sisters were placed at Epworth until a sustainable plan could be determined.

Eric is tall, soft spoken and respectful. When asked

about his school experience he responded, "I haven't been in school a whole lot." He came with no school records, so Mrs. Christy Mooneyhan, Epworth's Chief Academic Officer, went to work trying to discover as much as she could about his academic history. What she learned was troubling. "Eric is 17 years old, and has only five and one half credit hours," she said. "He can't graduate from high school this year with the other children his age." The more she learned the more troubling the news. Through years of experience, Epworth has learned that the majority of the children arrive performing an average of two grade levels behind their peers. Education is vital to helping break the cycle of abuse, neglect and shame they have experienced. Epworth administers an educational assessment to each new resident. The assessment revealed that Eric not only lacked the credit hours to graduate with a high school diploma,

In the year of 1895, the Methodist people of South Carolina authorized the founding of Epworth Orphanage in order to provide a Christian home for children who needed a place to live. Since that time, the children who reside at Epworth continue to receive generous support through church congregations in our state.

While Epworth does not receive financial support from the Denomination and is not an apportioned item that receives financial support from the South Carolina Conference of the United Methodist Church, Epworth does receive contributions from the majority of United Methodist congregations in South Carolina.

Two Sundays, Mother's Day in May and Work Day in September, are designated as Epworth Children's Home Sundays on which pastors are asked to highlight God's work through Epworth and receive a special offering for the support of the children of Epworth.

During the calendar year of 2012, \$1,454,903.89 was received from and or credited to the 1,014 United Methodist congregations in South Carolina. This total does not include "in kind" or volunteer work.

I am pleased to announce that the per member giving reached \$6.18 this past year, which means the goal of an average gift of at least \$6.00 per United Methodist in S.C. was achieved. 2012 church giving reports reflect the following for S.C. United Methodist.

- United Methodist in S.C. 235,501
- Average giving per member \$6.18
- Number of United Methodist Churches 1,014
- Number of congregations contributing at \$6 per member or greater – 321
- Number of congregations contributing \$0.00 239
- Number of congregations ordering Epworth offering materials – 431

On behalf of the staff and the children who live at Epworth, I thank everyone who has given and worked so diligently to reach this level of support. As we all see, this level of congregational support is crucial in providing the best possible care for our children.

Denominational support goals for 2013 are:

An average of at least \$6.00 per member from every United Methodist in S.C.; every congregation contributing at least \$6.00 per member; no "zero" congregations; and every congregation observing Mother's Day and Work Day by receiving an offering for Epworth's Children.

We celebrate the increase in congregational support, and know the best days are yet ahead for the children and families of Epworth.




### 2012 Revenue Sources **Total Revenue \$4,838,889**

but he also struggled with a learning disability that would prevent him from getting his GED.

Eric's hurdles didn't end with his academic challenges. When Epworth Case Manager, Ms. Brianna Guy, tried to talk to him about his future, his only response was, "I want to be a professional basketball player." Eric lacks the insight to see the truth of his own reality. He is very close to the age of 18 when he can legally sign himself out of Epworth's care. Knowing that he is not in a



position to support himself, the staff at Epworth have been diligent in helping him grasp his viable possibilities for his future.

Ms. Guy and others on staff spent numerous weeks, days and hours with Eric, introducing him to alternatives, but nothing swayed him from his idea of being a professional basketball player. Ms. Guy was concerned for Eric and his future. She had one final option, and she presented it to him. "Eric, what do you think about Job Corps?"

Eric, as he always did, graciously agreed to learn more about Ms. Guy's new ideas. Eric was polite and respectful during the conversation. He asked questions and interacted with Ms. Guy and his DSS Case Worker. After leaving the office he said nothing for a long while. "It was really quiet in the car," said Ms. Guy. "But then I asked him what he thought about the idea."

"I think I'd like to be a plumber," Eric said.

Ms. Guy was shocked. She was also delighted. It was the first time Eric had said anything that represented he might be beginning to comprehend the importance of this decision.

"A plumber?" she responded. "Yes. I think being a plumber would be good," he told her.

Eric has taken ownership in the first steps of a plan for his future. He and Ms. Guy returned to the cottage and begin thinking about what steps he needs to take to be accepted to Job Corps and begin his training as a plumber. This, albeit hopeful, is simply a start.

Not only does Eric need additional academic support, but he has also experienced a great deal of trauma. He needs therapy to help him heal from that trauma. He and his mother and siblings are in family therapy weekly. This service is offered to families free of charge. Epworth knows that in order to break the cycle, the behaviors of the families must change. Although Eric is 17, he is emotionally and developmentally younger than that. He misses his mother deeply and cries during the therapy sessions. The emotional hurt is great for him and often distracts him from moving forward with his life. Ms. Guy understands this and offers a great deal of patience as she gently directs and encourages him.

Eric's story is difficult. He has many needs that would never be met if Epworth provided only room and board. Eric knows what it means to walk miles of his life in pain, but now that he is at Epworth, he is learning what it can mean to walk in hope and new life. Epworth staff members, like Ms. Guy and Mrs. Mooneyhan, are going the extra mile for Eric and every child who calls Epworth home. They know what it takes to help break the cycle so that when the children leave Epworth's safety and security they will be better equipped to navigate life's many miles.

The mission of Epworth Children's Home is to serve children, youth and families through a caring, accepting and safe Christian community, where hurts are healed; hope is nurtured; and faith in God, self and others is developed.

The Friends of Epworth was formed by a small group of community leaders who began individually volunteering at Epworth Children's Home to give back to their community. Little did they realize how much their lives would be impacted by the children they served.
