The Rules of Love

“You’re the best mommy I could ever ask for.”

When 12-year-old Kylie first spoke those words to Epworth foster mom Jennifer Rule months ago, Jennifer nearly cried. It was, she said, a ‘melt’ moment.

“A melt moment is when we know we’re getting to them and they are getting to us,” Jennifer said.

Along with her younger brothers Connor, 9, and Jack, 6, Kylie has come a long way in the year-and-a-half since the three siblings were placed with Jennifer and her husband, Matt.

Kylie, especially, arrived laden with deep insecurities that could have led her to make self-destructive choices in a few short years.

“She believed false things – that no one loved her or would want her,” Jennifer said. “This made her very afraid to tell us what she really thought about things

because she was so anxious and worried about how we would react. We’ve been able to help her work on that so she is less afraid to speak truthfully to us, and we’ve helped her build up her sense of self value. I’m so glad she came to live with us when she did. I’m afraid that as a teenager, she might have been looking for anything that seemed to provide an ounce of security and affection, even if it was completely fake.”

Before the three siblings moved in with them, Jenn and Matt had already fostered 12 other South Carolina children, some for a few days, others for more than a year.

The couple, both in their early 40s, live in a rural Pee Dee town in a home that sits along a dirt road. Jennifer’s mom and stepdad live there too, along with an affectionate and playful Chihuahua-Pomeranian mix named Daisy. An uncle lives in waving distance.

A Message from Beth Williams
President and CEO

It's that time of year again when I have the wonderful opportunity to thank you immensely for helping Epworth to achieve the successes we have had over the past year. We have had an exciting 12 months, and the number of children and families who Epworth serves is greater than at any other point in the 128 years of our history. Our programs and services are growing and expanding as we continue to serve children and families on our two Columbia campuses, as well as in our regional outposts all over the state. Your support, interest, and enthusiasm have helped to make Epworth's successes possible.

As I write this letter to you for the annual report edition of *The Record*, we are not only seeing the new programs we have developed thriving, but we are also proud of the continuum of care that Epworth is able to provide when so many of our programs connect and complement one another, bringing comprehensive services to our state's most vulnerable children and families.

As you know, several years ago Epworth created the Institute for Child and Family Wellbeing which encompasses Epworth's current and expanding array of services and educational initiatives for children and families. Some of the major components include:

- a foster family identification and recruitment center;
- an early childhood education center that helps prepare children who need assistance to be ready to enter kindergarten and elementary school;
- a counseling center for both children and their families;
- a kinship program to help grandparents and other extended family members who are caring for children within their families;
- Circle of Parents® self-help groups for caregivers;
- a recognized independent living center for older youth who need specific guidance and support as they learn life skills, job skills, or continue their educations to prepare them for responsible adulthood;
- a family care center where mothers with addictions learn parenting skills and parental responsibility as they live on our campus with their children;
- and several other academic and focused programs that address the educational and social needs of the children who call Epworth their home.

This year, two of these programs received a special focus. Epworth received two large grants from the South Carolina Department of Social Services to develop and expand its kinship care programs in both the Midlands and in the Pee Dee areas of our state. When parents can't meet a child's basic needs or when a child is removed from the home due to abuse or neglect, relatives often must step in to care for the child. This is kinship care, and it can be temporary or permanent.

With the grant funding from the Department of Social Services, Epworth will train and support these grandparents, aunts and uncles, and other family members who assume responsibility for children in their

families when the parents are no longer able to care for their own children. This support will augment the work that Epworth is already doing to help and support kinship caregivers and will greatly allow for the expansion of the number of kinship families Epworth serves. In fact, using estimates from the Department of Social Services, Epworth expects to serve more than 600 kinship families in the next calendar year.

These services include kinship family members' access to Epworth's Center for Counseling where family members and the children they are caring for can receive various types of psychotherapy. Often children in kinship families use the services of Epworth's Early Intervention Center, where preschool age children with developmental issues are provided with academic programs and services so that they can enter kindergarten and elementary school at grade level competency.

Another integral way in which Epworth provides services to kinship families is through the unique partnership that Epworth enjoys with United Methodist Churches across South Carolina. Some of you may be members of churches that have directly supported kin caregivers in your communities by helping families with meals, providing transportation to doctor's appointments and meetings, and other specific needs that arise. The churches also act as liaisons with the Epworth campus so that they can help facilitate bringing kinship families from their communities to the Center for Counseling, the Early Education Intervention Center, or to other services Epworth provides on its campuses. Epworth also supports these kin caregivers by providing tangible assistance with supplies and equipment that the families need as they assume responsibility for a child in their family.

We are excited about the opportunity to work with more kinship families this year and to provide them with resources they need to succeed in providing safe, secure, and happy homes for the children in their care, and we continue to appreciate the help you, members of United Methodist Churches around South Carolina, provide to kinship caregivers in your communities.

We also are looking forward to the continuing expansion of services in the Epworth Early Intervention Center where preschool age children with developmental issues are provided with the academic resources they need to enter kindergarten and elementary school at grade level competency. We will have two Early Interventionists whose offices will be located in Ashland United Methodist Church. These staff members will primarily serve Lexington County.

I would like to share with you the story of a mother whose child was in the Early Intervention Center. Her three-year-old little boy, "Joe", began attending our preschool program. Joe's mother is a nurse and is the main supporter of her family. Joe is autistic and requires multiple therapies.

The Center has very low tuition rates and accepts the ABC Voucher, as well. The ABC Voucher is a great resource but does not pay tuition fully. Joe's mother applied for the ABC Voucher and was denied because her salary as a nurse was too high for public assistance. The mother has insurance; however, she must pay a large portion of Joe's medical expenses out of pocket. She found herself having to pick and choose between preschool and Joe's many therapies. Luckily, we have a benefactor who donates a two-day-a-week scholarship each year. Joe was able to receive this scholarship. And while the scholarship helped Joe, we have other children whose parents are having to make the same hard decisions to care for their children. To address this issue, Epworth donates two scholarships a year.

Over the coming months, Epworth will augment its many programs and services, expanding them to include more children and families across our state. To this end, Epworth's mission statement reads: "The mission of Epworth Children's Home is to serve children, youth and families through caring, safe, Christian communities, where hurts are healed, hope is nurtured, and faith in God, self, and others is developed." As we endeavor to make this mission statement a reality every day, we are grateful for all of you who appreciate Epworth's work and support us with your prayers, your volunteer work, and your contributions. I look forward to another exceptional year as we continue 2024 and move into 2025.

Circle of Parents®

Circle of Parents® is a peer-led parenting support group for parents and caregivers. It provides a safe place where anyone in a parenting role can openly discuss the successes and challenges of raising children and find support.

The Center for Independent Living and Transitional Independent Living Program

Epworth's Center for Independent Living serves clients ages 18-23 who are either employed or enrolled in educational programs, or both. Some previously spent time in foster care. Epworth's similar Transitional Independent Living Program serves clients ages 18-24 who were involved in the juvenile justice system. Many clients in these innovative Epworth residential programs earn college credits and vocational training certifications while saving money and receiving important life skills training in areas including drivers' education, personal financial literacy, cooking and self-care.

Family Care Center

The Family Care Center serves mothers with substance use disorders and their children. The families live together in a cottage on Epworth's campus and receive treatment as a family unit.

Residential Services

Epworth Children's Home residential care program serves children from throughout South Carolina. Children come to Epworth after experiencing significant trauma like grief, loss, neglect and/or abuse and live with us on our campus in cottages with caring staff. While living on our campus, they receive counseling, academic tutoring, recreational opportunities, and more.

HOMEBUILDERS®

HOMEBUILDERS® provides intensive, in-home crisis intervention, counseling, and life-skills education for families who have children at imminent risk of placement in state-funded care. It is the oldest and best-documented Intensive Family Preservation Services (IFPS) program in the United States. The goal is to prevent the unnecessary out-of-home placement of children through intensive, on-site intervention, and to teach families new problem-solving skills to prevent future crises.

Foster Care

Epworth licenses individuals and married couples across the state of South Carolina for both Family Foster Care and Therapeutic Foster Care. Foster families benefit from proven, research-based training and around-the-clock support from Epworth Foster Care staff members. The children who reside with private foster families can also benefit from the many additional services and resources that Epworth offers to families across its array of programs.

Early Intervention Center

The Early Intervention Center serves children with developmental delays and disabilities through the Home-Based Program as well as the on-campus Preschool Program.

The Epworth Center for Counseling is an outpatient counseling center for children, teens, and adults. Epworth's Intensive In-Home Services (IIHS) is a four-to-six-month program that provides an array of services and support to families who are involved with the S.C. Department of Social Services. 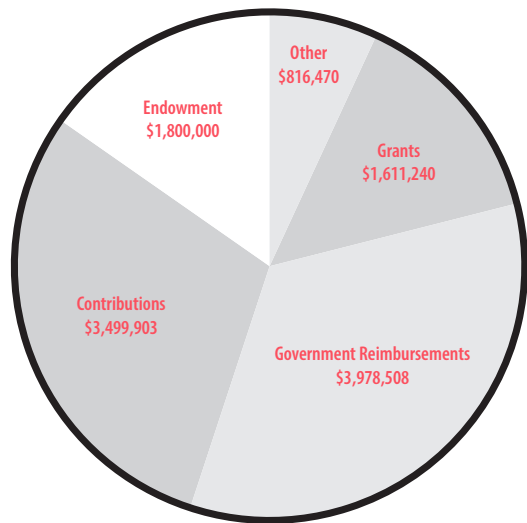

Epworth Academic Points of Interest 2022-2023

- During the 2022-2023 school year, 88% of residents tested below grade level in reading on initial assessment testing. By the end of the 2022-2023 school year, 77% of those residents had shown improvement in their reading scores on follow-up assessment testing. 41% of those residents improved their scores by more than a grade level.
- During the 2022-2023 school year, 90% of residents tested below grade level in math on initial assessment testing. By the end of the 2022-2023 school year, 79% of those residents had shown improvement in the math scores on follow-up assessment testing. 56% of those residents improved their scores by more than a grade level.
- During the 2022-2023 school year, 3,984 tutoring sessions were offered.
- During the 2022-2023 school year, the tutoring center provided 5 tutors, a Career Counselor, and an Academic and Behavioral Coach who served 103 residents.
- During the 2022-2023 school year, 81% of residents maintained an overall “C” average or higher.
- During the 2022-2023 school year, 97% of residents had 2 or fewer behavioral referrals during a quarter.
- 100% of seniors graduated or earned their graduation equivalency diploma (GED) at the end of the 2022-2023 school year. This is the 11th consecutive year with 100% graduation rate.

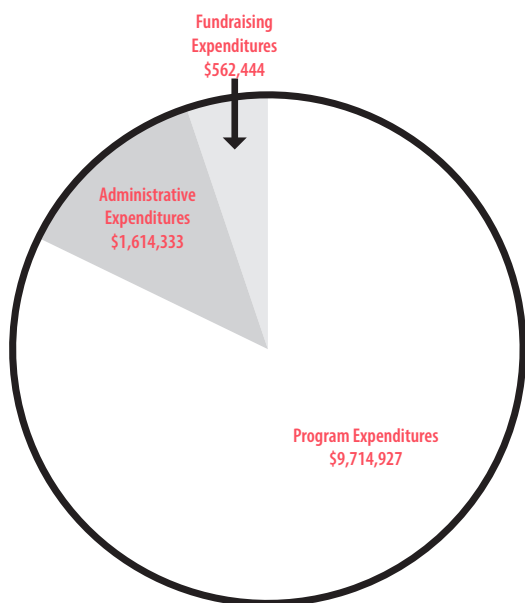


2023 Revenue Sources

Epworth's Annual Mother's Day Offering
Sunday, May 12, 2024

It was in this peaceful, family-rich setting that Kylie, Connor and Jack came to live after experiencing a home life where complicated problems kept their parents from being able to provide the care and stability the children needed.

Epworth's Pee Dee Foster Care Director Shannon Coates has worked closely with the Rules since they became licensed to foster several years ago.

"They are special people," she said. "The Rules have never said no when we called to ask if they would take a child. They've been willing to take children of any age, and because of that, have made a real impact. I've seen those three children change so much since they've been with them. It is amazing what happens when children feel safe."

Jennifer and Matt, who have adult children from prior relationships, decided to become foster parents after realizing how acutely they missed the lively chaos, rhythm and sounds of a home filled with children and adolescents. In researching fostering, they were especially saddened by stories of siblings being separated when taken into foster care, so they decided that keeping sibling sets together would be part of their personal mission. They said fostering not only fulfills their yearning for a full and joyful family life, it has also given them a powerful way to live their Christian values.

"We are here to take care of what God loves, right?" Jennifer said. "It's just like with our own birth families, we're here to come together as Christians to protect what He loves and ensure that the children He loves have the warmth and comfort that He would want them to have."

Shannon said that each Christmas, the Rules hang stockings for all the children they have fostered because they see them as "part of their forever family."

Jennifer and Matt say their success as foster parents stems from several things. Jennifer said she has found that sincerity and genuineness are crucial to helping children overcome trauma and anxiety.

"Children can feel the love come out of you and they can also feel fear and anxiety, they can feel all of it," she said. "What you pour out is what they gather. You want them to know that, come what may, we are going to struggle with this together and we will fix this together, no matter if you are here for a day or six years, we're going to work it out. And you let them know you want them to be here."

She also said that she has found that calming the oldest child in a sibling group helps the younger children feel safe because the younger children look to the oldest for cues.

Epworth staff have also been crucial, Jennifer said.

"I cannot stress enough how much anytime I have a question, Epworth staff are right there to answer it," she said. "If I need a resource, they will find it for me. I feel as though they are family too."

The Rules also focus on exposing the children to new, positive experiences. For instance, the Rules recently took Kylie, Connor and Jack on their first real vacation – a weeklong cruise.

"The excitement and joy in their faces, they just had a blast," Jennifer said. "Their eyes still light up when they talk about the day they went on the ship. It was so good, we have already booked another one for 2026."

The date is a long way off, but Jennifer and Matt are hopeful that the three siblings will still be with them when the time comes. The Rules have become deeply attached to the three children, and they were overjoyed to learn that they had been freed for adoption. Jennifer and Matt are praying that their petition to adopt will be approved.
